- (1) **Belarus, Cambodia, China, Cuba, Indonesia, Iran, Israel, Kenya, Laos, Malaysia, OAPI, Oman, Syria, Thailand:** In these countries records of existing licence registrations are mandatory.
- (2) **Brazil, Estonia, India, Namibia, Philippines:** A subsequent designation to these countries is only possible if the registration date of the international trademark is after the entry of the respective country to the Madrid System.
- (3) **OAPI Members:** Benin, Burkina Faso, Cameroon, Central African Republic, Chad, Comoros, Republic of Congo, Equatorial Guinea, Gabon, Guinea, Guinea Bissau, Ivory Coast, Mali, Mauritania, Niger, Senegal and Togo.
- (4) **BES-Islands:** Bonaire, Saint Eustatius, Saba
- (5) **Afghanistan, Lesotho, Namibia, OAPI, Sierra Leone, Eswatini (Swaziland), Zambia:** By experience, trademark rights are not enforceable in these countries by means of an International Registration and, therefore, national registrations are recommended instead.
- (6) **Member Country of the European Union**
